The Ride & Stride is organised by the Surrey Churches Preservation Trust which makes grants to Christian churches and chapels towards the cost of major fabric repairs.

Cyclists and walkers of all ages are invited to seek sponsors who will agree to pay an agreed sum for each church visited on 'Ride & Stride Saturday' or make a donation.

This year 33 counties, including neighbouring London, Kent, Berkshire, Hampshire and Sussex are organising sponsored rides on the same day. Churches in these counties can be visited by cyclists wishing to cross county borders.

Non-cyclists, especially in large towns, are welcome to walk between different churches if they wish.

BEFORE THE RIDE:

- Plan your route. Your local organiser has a list of participating churches
- Study the accompanying Safety Notes
- Check your bike is roadworthy, make sure you have a helmet and protective clothing

DURING THE RIDE

- Visit as many churches and chapels as possible; you may go by train or be driven to your first church and picked-up again from your last church
- At each church, get your sponsorship form signed

AFTER THE RIDE

- Collect your sponsorship money within four weeks and hand it to your church organiser or church office

THE GIFT AID TAX DECLARATION: I want the charity to reclaim tax on the donation detailed below, given on the date shown.
